On 12-10-12 at approximately 0255, the suspect and victim were at Incahoos Night Club at 711 Edison St. They both were intoxicated. They have been friends for a year. They became involved in an argument. The victim left the bar and started to run across the parking lot. The suspect followed her and tackled her to the ground. The victim called out for help. He tried to get her into his car. The victim was not wanting to go with the suspect. He took her belongings and put them in his truck. She went into the truck and they began to drive off when the victim jumped out of the truck. The suspect again tried to get the victim into the car and tackled her a second time.

The witness saw all this occur and called 911 and had both the victim and suspect sit down until police arrived. The victim had no visible injuries, although she complained of knee pain from jumping out of the car.

I arrived and spoke to the victim. The victim was very intoxicated, but she insisted that she was tackled. The suspect was also very intoxicated. He stated that was just trying to keep her from running off, for her safety.

The witness provided a written statement of her involvement and it was placed into the property room as evidence.

The suspect was arrested and transported to the PDF without incident. The suspect was cooperative during all phases of my investigation.
