On 3/19/14 at 0223 hours Ofc. B.G.Johnson #63439 and I were dispatched to the listed address (Taste bar/restaurant) in reference to a battery. Upon arrival we observed the listed victim being treated by JFRD rescue #28 for a stabbing injury to his left arm. Ofc. Johnson observed the listed knife with blood on it and secured it for evidence.

The victim was transported by JFRD to UF Health Hospital for medical treatment.

We entered the business and observed the listed suspect sitting on the floor being treated by JFRD for injuries to his head. We observed a large amount of blood on the suspect and several lacerations to his face and head.

PIC Ofc. M. Gazic #66786 arrived on scene.

The listed witnesses were also present and began providing statements to Ofc. Johnson and I stayed with the suspect. The suspect declined to be transported by JFRD to the hospital. I Mirandized the suspect via card. Post Miranda, I questioned the suspect about the incident. The suspect provided the following statement.

The suspect had been seated at the bar with a female friend since approximately 2200 hours on 3/18/14. The victim kept harassing his female friend by calling her a lesbian. The suspect got angry with the suspect and told him, "Hey nigger, she's with me." The suspect was alter standing at the side of the bar when he was attacked by an unknown number of males who threw him to the ground and started kicking and punching him. The suspect stated that he does not know how his kabar (knife) got out of his hip holster but denies using it to cut the victim. The suspect further stated that if he did use the kabar to cut someone, that "he did it for the right reason." He stated that he was in fear for his life while being beaten by the males. He stated that he had not been drinking at the bar, and later changed his story stating that he only had two drinks. The suspect stated that he was previously employed by the St. Johns County Sheriff's Office for five years and just got back from working as a private contractor for two years in Afghanistan. He stated that he suffers from hearing loss and head trauma as a result of injuries incurred while in Afghanistan.

I spoke to the victim at UF Health Hospital who provided the following statement.

The victim works as a bouncer/bartender at Taste. He was seated a few seats down from the suspect on the patron side of the bar. The victim heard the suspect claiming to be a part of the Outlaw motorcycle club and continually calling people niggers. The victim and Blasé (witness #3), an employee working at Taste at the time of the incident, approached the suspect to ask him to leave. The suspect was standing at the side of the bar with his hands on the bar. The victim and Blasé identified themselves as representatives of Taste and told the suspect that he had to leave. The suspect refused to leave. Blasé then took hold of one of the suspect's arms and the victim took hold of the other arm. At that moment, the suspect twisted away from them and grabbed something from his waistband and struck the victim in the right arm. The victim grabbed the suspect by the neck and wrestled him to the ground. The victim and Blasé wrestled with the suspect on the ground. Realizing he had been cut badly, the victim attempted to choke him in an effort to subdue him. Other unknown people assisted in holding the suspect down until police and JFRD arrived. The victim admitted to striking the suspect in the head with his fists during the incident.

The witnesses stated that the listed suspect had been drinking at the bar for several hours. During his time at the bar, the suspect repeatedly called black people "nigger".

Witnesses #1 and #2 were near the subject when the incident began. Both witnesses shared the same following account. The suspect had been "stalking" witness #1 all night inside Taste. Witness #1 stated that the suspect was "creeping her out all night." Both witnesses stated that Blasé and the victim approached the suspect to escort him out of the business. Both witnesses stated that they observed the suspect stab the victim with a knife before they went to the ground.

Witness #4 stated that he observed the victim having the suspect in a head lock. The suspect was yelling profanities and using the word "nigger." The suspect was yelling that he was an Outlaw. The suspect was fighting with the victim and another black male employee.

The suspect was absentee booked and taken to UF Health by Ofc. Johnson.

An ET was dispatched to UF Health to photograph the suspect's and the victim's injuries.

The management at Taste stated that they do not have any video surveillance footage of the incident.

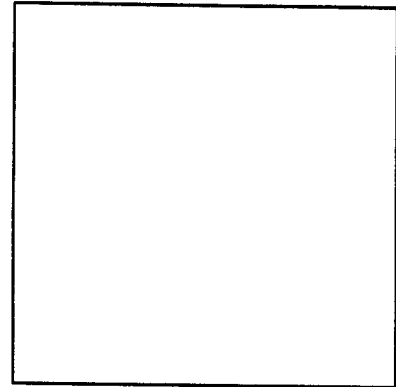
